<b>Prevention:</b>	Do not breathe dust or fumes. Wash affected area thoroughly after handling. Wear protective gloves, clothing, eye and face protection.

## 4. FIRST AID MEASURES

<b>Inhalation:</b>	Move to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention.
<b>Skin contact:</b>	Remove contaminated clothing and footwear. Immediately flush skin with plenty of water (using soap, if available). Get medical attention. Wash clothing before reuse. Thoroughly clean shoes before reuse.
<b>Eye contact:</b>	Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Get medical attention.
<b>Ingestion:</b>	DO NOT induce vomiting unless directed to do so by medical personnel. Get medical attention. Never give anything by mouth to an unconscious person. If a person vomits when lying on his back, place him in the recovery position.

## 5. FIRE FIGHTING MEASURES

<b>Extinguishing media:</b>	Water spray (fog), foam, dry chemical or carbon dioxide.
<b>Special firefighting procedures:</b>	Use water spray to keep fire exposed containers cool and disperse vapors. Wear self-contained breathing apparatus and full protective clothing, such as turn-out gear.

## 6. ACCIDENTAL RELEASE MEASURES

<b>Clean-up methods:</b>	Remove all sources of ignition. Evacuate and ventilate spill area; dike spill to prevent entry into water system; wear full protective equipment during clean-up. Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Scrape up as much material as possible. Keep in suitable and closed containers for disposal. ## 7. HANDLING AND STORAGE

**Handling:** Use only with adequate ventilation. Keep out of the reach of children. Make sure containers are properly grounded before use or transfer of material.
